This document describes the correct use of CENELEC and ATEX batteries for the Intrinsically Safe (IS) GP900, GP1200 and MTS2000 portable radios. The following table summarises the information contained in the remainder of the document:

## Usage of Intrinsically Safe Batteries: NTN7148 (CENELEC Battery) and RNN4008AR (ATEX Battery)

To address questions about the compatibility between the intrinsically safe radio model variants and their batteries, the following guidance has to be adopted for existing batteries NTN7148 and / or RNN4008AR.

These two variants are certified to one of the following intrinsically safe standards:

- CENELEC EEx ib IIC T4 (Original Standard Blue Dot)
- ATEX EEx ib IIB T4 (Revised standard Yellow Dot)

However the certification is only applicable when the correct battery and radio are used together. Should the battery and radio certification be different, then

- The intrinsic safety rating for the radio and battery combination is the lower of the two • separate IS ratings.
- A mixed certification, may lead to operational non compliance to IS standards •
- The use of an incompatible battery will reduce its capacity resulting in possible premature ٠ loss of communications.

The GP900 / GP1200 / MTS2000 model variant of Radios and Batteries can be easily identified by a coloured dot on the base of the radio:

# USAGE OF IS BATTERY RNN4008BR Dual battery

Dual marked battery for Cenelec (replacement for NTN7148) and ATEX (replacement for RNN4008ARA – ATEX / Cenelec battery)

The Nickel-Cadmium cells used within the dual marked Battery Pack RNN4008AR\_ have been replaced by Nickel-Metal-Hydride cells. These changes do not affect the original intrinsic safety assessment. Please note the following changes to the battery label:

- Cell chemistry changed from NiCd to NiMH
- Cell Origin Change changed to "Japan"
- Removal of NiCd related logo to NiMH.



## The coloured dot on the bottom label of the battery RNN4008ARA / BR has been removed.

Batteries with **Date Code 717** onwards can be used on Motorola's GP900 / GP1200 / MTS2000 CENELEC and ATEX approved radios.
